

Invitation to Bid

Rehabilitation of Perimeter Fence at the DSWD Field Office 02, Carig Sur, Tuguegarao city

1. The *Department of Social Welfare and Development Field Office 02* through the *Government of the Philippines, funded under P/A/P Capital Outlay* intends to apply the sum of *One Million Nine Hundred Ninety Nine Thousand Nine Hundred Sixty Pesos and 20/100 (P 1,999,960.20)* being the Approved Budget for the Contract (ABC) to payments under the contract for *Rehabilitation of Perimeter Fence at the DSWD Field Office 02, Carig Sur, Tuguegarao city*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Department of Social Welfare and Development Field Office 02* now invites bids for the above Procurement Project. Completion of the Works is required *for 60 Working Days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *Department of Social Welfare and Development Field Office 02 – Procurement Section* and inspect the Bidding Documents at the address given below from *8:00 AM – 5:00 PM*.
5. A complete set of Bidding Documents may be acquired by interested bidders on *April 29 – May 18, 2021* from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (P 5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the be it will be presented in person, by facsimile, or through electronic means.
6. The *Department of Social Welfare and Development Field Office 02* will hold a Pre-Bid Conference on *May 6, 2021 – 2:00 P.M.* at *DSWD Field Office 02 Conference Hall, Carig Sur, Tuguegarao City, Cagayan* and/or through videoconferencing/webcasting *via Google Meet*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before *May 18, 2021 – 2:00 PM*. Late bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **May 18, 2021 – 2:00 PM**. at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **Department of Social Welfare and Development Field Office 02** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
