Supply and Installation of OFF GRID Solar Panel at CVRRCY, Roma Norte, Enrile, Cagayan

- The Department of Social Welfare and Development Field Office 02 through the Government of the Philippines, funded under P/A/P RRCY 320101100001000 (5021304000) intends to apply the sum of Three Million Five Hundred Forty Two Thousand Nine Hundred Five Pesos and 80/100 (P3,542,905.80) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply and Installation of OFF GRID Solar Panel at CVRRCY, Roma Norte, Enrile, Cagayan. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The Department of Social Welfare and Development Field Office 02 now invites bids for the above Procurement Project. Completion of the Works is required for 60 Working Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- Interested bidders may obtain further information from Department of Social Welfare and Development Field Office 02 – Procurement Section and inspect the Bidding Documents at the address given below from 8:00 AM – 5:00 PM.
- A complete set of Bidding Documents may be acquired by interested bidders on December 7-27, 2021 from given

address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P 5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the bid it will be presented in person, by facsimile, or through electronic means.

6. The Department of Social Welfare and Development Field Office 02 will hold a Pre-Bid Conference on December 15, 2021 – 10:00 A.M. at DSWD Field Office 02 Conference Hall, Carig Sur, Tuguegarao City, Cagayan and/or through videoconferencing/webcasting via Google Meet.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before December 27, 2021 – 10:00 AM. Late bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.

9. Bid opening shall be on December 27, 2021 – 10:00 AM. at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Department of Social Welfare and Development Field Office 02 reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
