Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.
- 2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

- 3. Interested bidders may obtain further information from DSWD Field Office 02 Bids and Awards Committee (BAC) through the BAC Secretariat and inspect the Bidding Documents at the address given below during office hours, 8:00AM-5:00PM, Monday-Friday,
- 4. A complete set of Bidding Documents may be purchased by interested bidders from January 25, 2022- February 15, 2022 on the address below and upon payment of a non-refundable fee pursuant to GPPB Resolution No. 04-2012 dated February 24, 2012 in the amount of Five Thousand Pesos (P 5,000.00)
- 5. A pre-bid conference will be conducted on February 2, 2022 at 2:00 P.M. at the DSWD Field Office 02, Brgy. Carig, Tuguegarao City which shall be open to all interested parties who have/haven't purchased the Bidding Documents. Prospective bidders may participate through video conferencing via Google Meet.
- 6. Bids must be delivered to the address below or it can be sent thru email with password protected on or before February 15, 2022 at 2:00 P.M. All bids must be accompanied by a bid security in any of the acceptable form and in the amount stated in Instructions to Bidders Clause 18.

Bid opening shall be immediately after the deadline for the submission and receipt of bids February 15, 2022 at 2:00 P,M, to be held at DSWD Field Office 02, Brgy. Carig, Tuguegarao City, Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 7. The Department of Social Welfare and Development Field Office 02 reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
