The Department of Social Welfare and Development, through the Government of the Philippines, funded under P/A/P 10000010001000 GASS intends to apply the sum of One Million Eight Hundred Ninety Eight Thousand Eight Hundred Eight Pesos and 25/100 (P1,898,808.25) being the Approved Budget for the Contract (ABC) to payments under the contract for Repainting of DSWD Field Office 02 Main building.
