Invitation to Bid for the Repainting of DSWD Field Office 02 Main Building

The Department of Social Welfare and Development, through the Government of the Philippines, funded under P/A/P 100000100001000 GASS intends to apply the sum of One Million Eight Hundred Ninety Eight Thousand Eight Hundred Eight Pesos and 25/100 (P1,898,808.25) being the Approved Budget for the Contract (ABC) to payments under the contract for Repainting of DSWD Field Office 02 Main building. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Department of Social Welfare and Development now invites bids for the above Procurement Project. Completion of the Works is required 90 working days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

4. Interested bidders may obtain further information from Department of Social Welfare and Development and inspect the Bidding Documents at the address given below from 8:00 AM – 5:00 PM.

A complete set of Bidding Documents may be acquired by interested bidders on July 20- August 9, 2022 from given address and website/s below {Insert if necessary: and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P 5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.

9. Bid opening shall be on August 9, 2022 @ 10:00 A.M. at the given address below DSWD Field Office 02 Conference Hall, Carig Sur, Tuguegarao City, Cagayan. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Department of Social Welfare and Development reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
