### Description

The Department of Social Welfare and Development through the Government of the Philippines (GOP), funded under P/A/P QRF 330100100003000 intends to apply the sum of Seven Million Nine Hundred Twenty Six Thousand Nine Hundred Fifty Four Pesos (P7,926,954.00) being the ABC to payments under the contract for Supply and Delivery of 86,672 Tins of Canned Tuna Flakes Etc. (1 Lot) for the Production of 22,500 Family Food Packs to be used as Stockpile and to be prepositioned to different LGUs of Region II. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from Department of Social Welfare and Development and inspect the Bidding Documents at the address given below from 8:00AM-5:00PM, Monday-Friday.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on October 8-31, 2022 from the given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos (P 10,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees personally.
- 6. The Department of Social Welfare and Development will hold a Pre-Bid Conference on October 17, 2022 @ 11:00 A.M. at Department of Social Welfare and Development Field Office 02, Conference Hall, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before October 31, 2022 @ 11:00 A.M. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on October 31, 2022 @ 11:00 A.M. at the Department of Social Welfare and Development Field Office 02, Conference Hall. Bid will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Department of Social Welfare and Development reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
