

Invitation to Bid for the Supply and Delivery of 40 Pieces Laptop Etc. (1 Lot) to be used for various Offices to support operations

- The Department of Social Welfare and Development through the Government of the Philippines (GOP), funded under P/A/P ICTMS 200000100001000 intends to apply the sum of Two Million Seven Hundred Fifty Thousand Pesos (2,750,000.00) being the ABC to payments under the contract for Supply and Delivery of 40 Pieces Laptop Etc. (1 Lot) to be used for various Offices to support operations. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Department of Social Welfare and Development now invites bids for the above Procurement Project. Delivery of the Goods is required by 15 Calendar days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the project from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from *Department of Social Welfare and Development* and inspect the Bidding Documents at the address given below from 8:00AM-5:00PM, Monday-Friday.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on November 25- December 19, 2022 from the given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P 5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees personally.

- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on December 19, 2022 @ 10:00 A.M. at the *Department of Social Welfare and Development Field Office 02, Conference Hall.* Bid will be opened in the presence of the bidders' representatives who choose to attend the activity.

The *Department of Social Welfare and Development* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
