

# Contract Agreement Form for the Procurement of Goods

## CONTRACT AGREEMENT

THIS AGREEMENT made this \_\_\_\_\_ day of \_\_\_\_\_ 2024 between **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE 02** of the Philippines (hereinafter called "the Entity") of the one part and **FIXIE COMPUTER VENTURES** of Unit 4 TNB Place Caritan Sur, Tuguegarao City, Cagayan, Philippines, Philippines (hereinafter called "the Supplier") of the other part.

WHEREAS, the Entity is desirous that the Contractor execute the **Supply and Delivery of Printers and Other ICT Equipment for Pantawid Pamilyang Pilipino Program** (hereinafter called "the Works") and the Entity has accepted the Bid for **Two Million Five Thousand One Hundred Fifty Pesos (P2,005,150.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - I. the Bid Form and the Price Schedule submitted by the Bidder;
  - II. the Schedule of Requirements;
  - III. the Technical Specifications;
  - IV. the General Conditions of Contract;
  - V. Special Conditions of Contract; and
  - VI. the Entity's Notification of Award.

Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;


- I. Performance Security;
- II. Notice of Award of Contract and the Bidder's conforme thereto; and
- III. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.


